(v) **Deficiencies observed by NCISM :** The shortcomings mentioned in clause 4 and requirements as per clause 8 of the NCISM, New Delhi letter referred above may please be fulfilled and the compliance letter to be forwarded directly to NCISM, New Delhi with a copy of the same shall be forwarded to the University by 31 Dec 2024.

- 1) This Continuation / Extension of affiliation is issued for the A.Y. 2024-2025 subject to the permission of NCISM / Govt. of India / Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
- 2) The admission shall be done through the Competent Authorities only.
